- (2) The Senior District 15 Director will serve as the Chair of the Region 6 Board of Governors until the Region 6 Society Director is elected for FY 2007-08.**

**(3) The term of office shown begins at the time of the ASCE Annual Meeting of the first year and end at the time of replacement during the ASCE Annual Meeting of the second year shown.**

**(4) To take office in October of a particular year, the nominee will be interviewed and approved by the nominating committee in February of the same year.**

**Notification of nominee or nominees to National will be by March 1 of the same year.**

**(5) The Senior District 15 will appoint the Interim Region 6 Governors until the election and installation of an Elected Region 6 Governor.**

**(6) The Junior District 15 Director may attend the Region 6 Board of Governors meetings in an ex officio capacity.**

**(7) The Senior District 15 Director makes the following appointments to become effective with the approval of the organizing documents of Region 6 by ASCE.**

**Governor 1: Conrad Keyes – One-year term**

**Governor 2: Fred Wagner – One-year term**

**Governor 3: Rob Haskins – Three-year term**

**Governor 4: Bob Patton – Three-year term**

**Governor 5: Wayne Koltz – Two-year term**
